



<p style="text-align: center;">AIRPORT RATES AND CHARGES October 1, 2011 to September 30, 2012</p>

Landing Fees

- All Aircraft - **\$2.64** per 1,000 lbs. Maximum Gross Landed Weight

Terminal Rental Rate - Includes ATO, BSO, ticket counter, back offices, operations space and curbside check in

- **\$87.58** per sq ft – All Signatory carriers
- **\$96.34** per sq ft - All Non Signatory

Gate Area Charges (Signatory airlines only)

- Each preferential gate position annual fee is **\$247,038** (billed monthly)

Apron Area Charges (Signatory airlines only)

- Each apron area annual fee is **\$98,730** (billed monthly)

Baggage Area Charges (Signatory airlines only)

- Total annual requirement is **\$5,311,728**
- Requirement to be allocated monthly to the Signatory airlines based on a split of 20% fixed and 80% variable based upon percentage of enplanements (including each respective affiliate)

Airport Facility Charge (Non Signatory and Affiliate)

- These charges are for all Non Signatory and Affiliate users of the airside terminal components which include Gate and Baggage areas.
- Charges are based upon average number of seats per aircraft type
- Non Signatory Charge **\$4.40** per seat per turn (Gate & Baggage)
 - See attached schedule for specific aircraft charge
- Affiliate Charge **\$2.20** per seat per turn (Gate and Fixed Portion of Baggage)
 - See attached schedule for specific aircraft charge

Equipment Use Charges (Non Signatory)

- These charges are for all Non Signatory users of the airside Port Authority equipment
- Jet Bridge per turn includes power usage **\$165**

Equipment Use Charge (Signatory & Affiliate)

- These charges are for all Signatory & Affiliate users of the airside Port Authority equipment
- Jet Bridge per turn includes power usage **\$85**

Apron Use Charges (Non Signatory)

- These charges are for all Non Signatory users of the Port Authority Apron
- Apron Use Charge per turn **\$66**

Apron Use Charge (Signatory & Affiliate)

- These charges are for all Signatory & Affiliate users of the Port Authority Apron
- Apron Use Charge per turn **\$55**

Commuter Apron Use Charge

- These charges are for all Commuter users of the Port Authority Apron
- Apron Use Charge per turn for aircraft 12,500 lbs or less **\$5**
- Apron Use Charge per turn for aircraft exceeding 12,500 lbs **\$15**

Airport Terminal Equipment Charges (Common Use)

- These charges are for all users of landside Port Authority equipment
- Common Use Terminal Equipment. Based upon the average number of seats per aircraft type. Charge is **\$.50** per seat per turn with a maximum of **\$100** per turn
- Common Use Baggage Makeup space with a bag belt. Based upon the average number of seats per aircraft type. Charge is **\$.50** per seat per turn with a maximum of **\$100** per turn
- Ticket Counter Space per 2-positions. Charge is **\$115** per turn
- Curbside Check-in Space per 2-positions. Charge is **\$25** per turn

Passenger Facility Charge (PFC)

- **\$4.50** per enplaned passenger

Passenger Aircraft Parking Fees (Off Gate):

- 1st **3 hours** or fraction thereof: **\$48**
- Each additional hour or fraction thereof: **\$6**
- **\$100** maximum each 24 hour period

Cargo Aircraft Parking Position Fee

- 1st 6 hours or fraction thereof: **\$48**
- Each additional hour or fraction thereof: **\$6**
- **\$100** each 24 hour period for aircraft 12,500 lbs or less
- **\$275** each 24 hour period for aircraft exceeding 12,500 lbs

***Please note that while the Airlines are required to self report monthly flight activity, the Lee County Port Authority utilizes an automated landing fee system to calculate actual landed weight and number of flights.**
